Zajak Drive Trail

The Zajak Drive Multi-Use Trail Project adds greater access into the Village Forest Park. Construction began construction on March 27th and is scheduled for substantial completion by mid-May. The project includes construction of a paved trail along the north side of Zajak Drive, extending from Connie Road to the west end of the recently constructed parking lot for the West Baraboo Village Forest Park. This project received funding through the Wisconsin DNR Recreational Trails Program.



Haskins Park Pickleball Courts

The Haskins Park Pickleball Courts Project is scheduled to begin construction in late April and is scheduled for substantial completion by mid-June. The project includes construction of two pickleball courts within Haskins Park, located between the existing volleyball courts and playground area.
